As required by §IX. Reporting Requirements of the Consent Decree associated with the above referenced civil action, we are submitting the following document for your review and comment:

- June 1, 2016 – 2016 1st Quarterly Report

Per our correspondence dated March 15, 2016 and May 3, 2016 and as discussed in our meeting on April 14, 2016, the County has become aware of inconsistencies in the reporting of Sanitary Sewer Overflows (SSOs), and how certain County staff has responded to such events. As a result of these apparent inconsistencies, the County is undertaking an in-depth review of its Service Requests and other records dating to the beginning of the Consent Decree period in order to verify the number of SSOs reported and analyzed. At the end of this review, the County may need to update information previously reported to EPA and EPD. The County has committed to having this comprehensive review completed in June 2016 and any such updates that may prove necessary, submitted to both EPA and EPD by July 31, 2016. The review is progressing and the County remains committed to meeting these dates.


As a part of this comprehensive review, the County is in the process of reviewing every Service Request received during the entire consent period and has completed a comprehensive review of each Service Request generated during the 1st Quarter, 2016. Section I of the attached 2016 1st Quarterly Report reflects the result of such review and is presented in a format that is consistent with previously submitted Quarterly Reports. In addition, the attached 2016 1st Quarterly Report includes a new Section II. As you will recall, the County was asked at our meeting of April 14, 2016 to begin tracking SSO's that appear to be caused by blockages or other issues located in that section of a private service lateral that is in the County's right-of-way. As this request was

not made until after the completion of collection of 1st Quarter data, some Service Requests did not include enough details from the caller or the responding crews to definitively determine if an issue within a private service lateral was within the County's right-of-way or was on private property. Out of an abundance of caution, those situations in which such questions remained have been included in Section II of the attached. As has been previously communicated, the County has revised the service request forms and is retraining all response crews on the level of detail required in such reports. As these changes were implemented during the 2nd Quarter of 2016, the County anticipates having all necessary information to accurately track such issues for inclusion in the 2016 3rd Quarterly Report.

I certify under penalty of law that these documents and all attachments were prepared under my direction or supervision in accordance with a system designed to assure that qualified personnel properly gather and evaluate the information submitted. Based on my inquiry of the person or persons who managed the system, or those persons directly responsible for gathering such information, the information is, to the best of my knowledge and belief, true, accurate and complete. I am aware that there are significant penalties for submitting false information, including the possibility of fines and imprisonment for knowing violation pursuant to CWA section 309(c)(4).

* The County was asked at our meeting of April 14, 2016 to begin tracking SSO's that appear to be caused by blockages or other issues located in that section of a private service lateral that is in the County's right-of-way. As this request was not made until after the completion of collection of 1st Quarter data, some Service Requests did not include enough details from the caller or the responding crews to definitively determine if an issue within a private service lateral was within the County's right-of-way or was on private property. Out of an abundance of caution, those situations in which such questions remained have been included in this Section II. As has been previously communicated, the County has revised the service request forms and is retraining all response crews on the level of detail required in such reports. As these changes were implemented during the 2nd Quarter of 2016, the County anticipates having all necessary information to accurately track such issues for inclusion in the 2016 3rd Quarterly Report.
